Do residents know that the HRC is a place to file a bias complaint? Could we promote it on social media, and the website. There are simple things we could do.

There is interest to take human rights a step further to social justice (from the training).

Create an environment for people who are interested in human rights. Possibly hold a meeting twice a month. How do we get more community involvement? Maybe a listening session at a Brooklyn Park Community Assembly/ Partner with Community Engagement.

Possibly, think of some sort of human rights award.

Back in 2005, the Human Relations Commission became Human Rights Commission.

Could there be an open forum for the HRC meetings?

Need clarity on when a complaint comes in, what’s the process? What’s the HRC’s role?

The HRC will work on revising content for the website.

Commissioner King may be interviewed for next year's videos.

Regarding offering scholarships to lower barriers to explorer programs, what strikes us as actionable that the HRC could endorse or support?

Could there be requirements to length of time an organization can require a person to work if they have training from the organization?

2. PeopleFest! 2020 – Yerks stated they received a preliminary grant for \$10,600 and will use it for the following: \$3,000 for performers, \$542 in mini grants to pay exhibitors, \$3000 for interactive art, and \$2100 for the kickoff event, which will take place on July 31<sup>st</sup>. The Native Pride Arts will be performing. There will be a little extra money left over and that will be used for additional things coming up. Chair Leeper asked about year 4 funding for this looks like and have there been any discussions on that. Chair Leeper said they would like to keep this a free event. The Party People Subcommittee Meeting will be on Friday December 20<sup>th</sup> at 9 am at the Art Center. The PeopleFest! Steering Committee will be on Monday January 6<sup>th</sup> at 4 pm at the Community Education Center.
3. HRC Municipality Index Released – EP Scored - Yerks said this organization does municipality indexes every year. Eden Prairie was one city selected to participate. There were 506 cities accessed across the US. Minneapolis/St. Paul scored 100, and Eden Prairie scored 49. Yerks said this index can help Eden Prairie reflect upon the ability to improve on things such as, non-discrimination laws, municipality as employer, municipal services, law enforcement and leadership on LGBTQ equality.
4. Star Tribune Article about Refugee Resettlement Requirements – There was an executive order that was passed recently for approval for refugee settlement. Counties across Minnesota need to opt in to this. The article does state that Hennepin County is looking into this.

Chair Leeper wanted to discuss the student project and asked if the project would align with Culture N Motion. Steidle stated it would and that it would take place in the Eden Prairie Activity Center from 2:30-4 pm. Chair Leeper asked if this would be targeted to high school students or the general public. Steidle said they would like it open to all; students and the general public. Chair Leeper asked, in terms of clubs, would the presenters be high school students. Steidle said she would like to see a balance of students and teachers. Ali said she does not attend the high school but would like to bring the Somali community there. Chair Leeper asked what date they had in mind. Steidle said sometime between mid and late April and would like to call the event Passport to Pop Culture.

Chair Leeper asked how many Kickin' it with the Cops events the Commission would like to do with Eden Prairie Police Department. Elassar suggested the Commission does just one event so it can be done well but also said if there is help from the police department, she would not be opposed to two events. Skeie said he would be interested in this subcommittee and echoes Elassar's suggestion that one would be good but we could do two with the help of the police department. Skeie said if two events are held they should be in different locations. Yerks suggested one big event with food and fire trucks and then a smaller event. Aman said he would like to do two events and liked the idea of one big event and one smaller event. Chair Leeper suggested the subcommittee work with the police department for dates. Yerks suggested July for the main event.

Yerks wanted to discuss PeopleFest! and suggested not to host a stand-alone event but be on a subcommittee. Aman agreed with Yerks and Skeie said he agrees we should not do a stand-alone event; Missaghi and Philmon concurred. Yerks inquired about meeting in August since PeopleFest! often interferes with the August meeting. Chair Leeper said to leave the meeting scheduled as is and see how it goes as we get closer to the date.

Yerks said there were four tabled events; 100 Anniversary of Women's Right to Vote; Culture N Motion; Listening Session and HTC Partnership. In regards to HTC Partnership, Chair Leeper said since the Commission has nothing planned to keep it tabled; the Commission concurred. For Women's Right to Vote, Elassar pointed out Women's History is in March and so they could post something on the City's website in regards to this topic. For Listening Sessions, Chair Leeper said when he first started on this Commission there was Coffee with the Council round table where community members could ask questions. He wanted to know if there was value in this event. Missaghi said he feels more people would like to see this event. Yerks purposed that at all events they have a Message to the Mayor table or box so community members can share with the Commission and City Council. This could also be a table at PeopleFest! Aman asked if would could invite the Mayor and Council Members to events. Yerks said that would be possible. Skeie suggested putting more emphasis on the advisory level. Chair Leeper said the goals are facility connection and the Commission needs to market this as well. Yerks said we would need to fine tune this event. Chair Leeper said the box is a good idea and so is inviting elected officials to events.

Elassar said in regards to the Quality of Life Surveys 2018, the sense of community among Eden Prairie residents is 68%. She said this was on the Eden Prairie website and will send it out to all Commissioners. Yerks said this could be an area where the community is encouraged to give feedback about areas for improvement.

Chair Leeper asked if Culture N Motion would be valuable to do this year. Aman said the schedule does look pretty labor intensive for January through to the summer. Chair Leeper said the value would be the people we bring together and commented he would hate to see this let go. Missaghi said he thinks it is worth doing and we could possibly partner with Mark Weber on this. Philmon said she likes the idea of this. Chair Leeper suggested putting it tentatively in October and see if we can partner with Mark Weber.

Chair Leeper discussed the subcommittees below and asked for volunteers. They are as follows:

## 2019 Overview

The Golden Valley Human Rights Commission led several initiatives in 2019. Not only did the Commission focus on some of its annual events and programs, they explored opportunities to engage with community members through new programming, events, and activities.

### Budget

For 2019, the City Council approved a budget of \$3,500.

The Commission spent \$2,466.85 (70 percent) of its budget for professional fees for speaker honorariums; cash prize for the 2019 MLK Literary contest winner; promotional stickers and bookmarks; hosting a booth at GV Pride festival; and tickets to sponsor two tables at the 2020 Martin Luther King, Jr Holiday Breakfast.

### Meetings

The HRC held eleven regular meetings, one special meeting in January, and had an option to attend the joint Board/Commission/City Council meeting in January.

### 2019 Work Plan Accomplishments

Beyond setting a work plan of specific activities and events, the Commission set specific goals for the year:

- Partner with other City human rights commissions and community service organizations on educational or outreach opportunities.
  - Explore opportunities to educate the community on voting rights.
- Update and enhance communication strategies (including providing resources through the City website).

The Commission successfully achieved all of these goals in 2019.

## Quarter 1: Jan-Mar

### 29th Annual MLK Holiday Breakfast

The Commission purchased one table (10 tickets) for the General Mills Foundation 29th Annual MLK Holiday Breakfast, and all 10 tickets were distributed.

### Sweet Potato Comfort Pie

The Commission sponsored three speakers at the Annual Sweet Potato Comfort Pies event held at Brookview Jan 20, 2019. Several Commissioners also volunteered at the event as well. The winner of the 2019 MLK Literary Contest presented her submission.

### Hopkins High School Sophomore Wins HRC Literary Contest

The winner of the Golden Valley's second annual Martin Luther King Jr Literary Contest is Brynn Hirsch, a student at Hopkins High School.

Sponsored by the Golden Valley Human Rights Commission (HRC), the contest is meant to honor the birthday and legacy of Dr Martin Luther King, Jr.

Students in grade 6–12 in Hopkins, Robbinsdale Area, Perpich, and Breck Schools entered written or audio/video work answering questions on the theme "Taking A Stand."

Hirsch, an active participant in the Hopkins High School Theater Department and a volunteer at the Hopkins Library, took first place for her essay on political protests despite doubting herself and her piece

"I had kind of convinced myself it wouldn't be me," she said. "But I was honestly so surprised and so happy and honored," she said.

When deciding to write the essay, Hirsch said it wasn't very hard to choose between the two prompts.

"I was more drawn to the second one, about participating in political protests because I already had some level of experience with it," Hirsch said. "I could draw from personal experience and the experiences of others I know, to try to convey how I feel when I speak up for change."

In addition to her prize, Hirsch also won tickets to the Jan 21 Minneapolis MLK Day Celebration and was invited to present her piece at the Jan 20 Martin Luther King celebration at Brookview.

## Quarter 3: Jul-Sep

### Week of Service

The Commission chose to promote a “week of service” donation collection for Prism during the week of Sept 11. Donation boxes were set up at City Hall, Brookview, and the Public Safety building for the week. It was promoted on social media and through CCX media.

Several Commissioners also volunteered to do park clean up at Sochacki Park on Saturday, Sept 7, 2019. Several Commissioners worked for four hours cleaning up and removing buckthorn from one of the City’s parks.



### Antisemitism, Xenophobia, and Hate: Local and Global Challenges Event

The Commission worked with World Without Genocide to host a program at Brookview on critical human rights issues and provide suggestions on how individuals and cities can respond. The program also reviewed current data on hate crimes, episodes of violence, and hate speech, with a focus on how to address multiple forms of hate.

## Quarter 4: Oct-Dec

### Why Treaties Matter Exhibit

The exhibit, presented by the Minnesotan Indian Affairs Council, Minnesota Humanities Center, and the Smithsonian's National Museum of the American Indian, features stories and voices of Dakota and Ojibwe Nations. It emphasizes American Indian independence as an ongoing continental reality and highlights the innovative ways the Dakota and Ojibwe Nations self-govern, create community, build sustainable systems, and relate to one another.

The HRC partnered with the Hennepin County Library in Golden Valley to promote the exhibit and highlight the topic of Native American treaties.

### Bill Hobbs Award

The Commission received two nominations. After discussion at the November meeting, the Commission selected both nominees as winners for the 2019 award. Ruth Paradise was nominated for her work to preserve and create affordable housing in the City. Paradise chairs the Golden Valley Affordable Housing Coalition and is a member of the Rising TIDES Task Force. Gloria Peck was nominated for her frequent volunteer efforts with PRISM, her leadership with Spirit of Hope Church, and her work as an original organizer of the Golden Valley PRIDE festival. Peck also served on the Human Rights Commission for just over six years, where she led several committees on topics like sex trafficking, LGBTQIA+ rights, mental illness, voting rights, and more. Both Peck and Paradise were presented the award at the City Council meeting Dec 17, 2019.




